



Local Cremation Service & Administration Fees

Our Local Cremation Service & Administration Fees include, but are not limited to, the following:

A beautiful Funeral Service delivered by the Funeral Director, or other appropriate person of your choice, with your loved one present. This package includes the extensive services of the Funeral Director and our appropriately trained staff to consult with family members and any third party organisations to arrange and deliver a personalised event. This will ensure the days' proceedings occur seamlessly.

We provide safe care and shelter for the remains of your loved one. Our Funeral Director gently prepares your loved one for the service and the cremation under strict infection control processes in an AFDA industry approved safe setting.

Our Funeral Director completes and submits all the necessary official documentation, notices and paperwork relating to the delivery of this event and the cremation.

We obtain legal authorisations and permits to complete the funeral service and the cremation. This includes coordination between the crematoriums and any other necessary third parties.

Our Local Cremation package fees cover the removal of your loved one from their place of death**.

Our Local Cremation package fees cover transfer mileage to the crematorium for the cremation (Strictly No Attendance)

This package also allows for proportionate costs attributed to;

The provision of Attendance Cards that are handed out to Funeral Attendees on the families behalf and presented to the family.

Funeral Director Licence Fees from Government Offices to allow the cremation to occur



Public Liability Insurance and Workers Compensation Insurance required by Government Offices before a funeral can be undertaken.

Australian Funeral Director Association (AFDA) fees which benefit clients with agreements and schemes such as offered by Retirees, WA.

APRA fees via AFDA to allow us to play music at public events without compromising on the artists copyrights.

Music streaming subscriptions to Apple, You Tube Premium and Spotify to allow for legal downloading and use of music for funeral services.

We can place Funeral and Death Notices on your behalf

We can support you with deciding on and ordering floral arrangements.

Our Professional Fee also partly contributes to the use of associated mandatory safety equipment that is fit for purpose and required to fulfil our duty to you and your loved one.

Part of our offering to you includes paying any incidental external fees relating to this funeral. These fees are over and above the price shown here, and we call them **Cash Disbursements**. These costs will be itemised on your account.



They can include, but are not limited to:

Shire or Crematorium Fees
Minister or Celebrant gratuities
Newspaper notices
Floral orders

Our Graveside Set Up service can be added for an additional fee, which allows access to our marquee, chairs, and provision of bottled water for the comfort of your family and friends at the graveside.

** Please note that Removal & Transfer costs are extra and include mileage, time and running cost. For instance a return trip to Perth will be a minimum of 7 hours and usually longer including hospital waiting time. If the deceased is collected outside the **Merredin** townsite, then transfer fees from the place of death will apply at **\$4.00 per km**. If the burial takes place outside the **MERREDIN** town site then additional Hearse mileage will apply at **\$5.00 per km**.
